National President's Report Roina Faatauvaa-Vavatau

This year has not been a smooth sail for the SUNGO Executive Council. Since our last AGM, in November, 2015, funding had been our major challenge not only for the Secretariat but also for the entire CSO network. This was largely due to CSSP being under review, which had been the sole funding mechanism for all Civil society organizations.

Hence, stringent measures were taken to minimize operational cost through the reduction of staff and service delivery, whilst ongoing negotiations were being made with donors. SUNGO is in a more stable financial situation now, not only being diversely funded and not relying on one donor, but has a more promising funding arrangements under CSSP.

At the National Level, your Executive Members have continued to representatives SUNGO and civil society on several Sector Committees and public consultations. Though much can be made to improve our Thematic Groups, to enhance local participation, and information sharing, we can only rely on the feedback from our Members Meeting and CSO forums to gauge your views and feedback. This has secured our CSO space and maintain the alignment of services with line Ministries in meeting National Priorities and the needs of our people. Similarily, SUNGO continues to be an active CSO representative at international platforms, sourcing information and engaging in dialogues on global trends, issues and opportunities as independent development actors.

Overall, the governing of the organization would not have been possible without the team work and collaboration of your Executive Council. They have reviewed the Constitution and the Strategic Plan, incorporating changes for a more effective institution and will be distributed for your consideration and approval. I am most humble at the indulgence of our members during the period of hardship. We regret not delivering timely services, due to constraints in this financial period. Your strength has been our strength, to keep on going.

We are indebted to the invaluable support of our Government and Development partner who have supported us through. We also acknowledge, our long time technical advisors John and Mary Cretney for their voluntarily support and advise to the staff and Executive in times of need. To all the SUNGO staff especially Rosa Maulolo and Faapito Opetaia for their commitment that kept the office going. Last but not least to all those who have served as Executive Members, Malo Faafetai tele. In God nothing is impossible. Together we have all made it through.

May the spirit of Christmas fill your homes and families with Joy and Happiness.

National Treasurer's Report Pesetā Malōuamaua Afoa Arasi Tiotio

As National Treasurer, I am pleased to present SUNGO's Annual Audit Report for the year ending 30 June 2016

Background:

The 2015/2016 financial year has been a very difficult year for SUNGO because of the absence of core funding. The majority of SUNGO's funding for the 2015 year came from the Civil Society Support Programme (CSSP), and 2015 was the final year of CSSP funding. The Executive Council in its efforts to ensure survival and continuation of service provision to our members during this difficult financial time, some very difficult decisions had to be made including imposing of strict controls on spending, as well as prioritizing staffing needs which had led to the CEO position being vacated until we have sufficient funding again.

i: Financial Position

Total assets at end of 2016 stood at \$985,517.00 compared to \$1,101,252.00 at the end of 2015. The two major items contributing to this decrease have been breaking of one \$50,000.00 fix deposit, and depreciation of our building. Current assets although reduced from \$481,173.00 in 2015 to \$389,491.00 at the end of 2016, it still represents a good liquidity position for the organization.

Total liabilities saw a significant reduction from \$180,972 in 2015 to \$94,965 in 2016, due mainly to the completion of donor funded projects.

Total accumulated funds stood at \$890,552.00 in 2016, compared to \$920,280.00 in 2015. It must be noted that there was no change in the value of our land asset at Vaitele although it is appreciating every year.

ii: Financial Performance

Income:

Total income was significantly reduced from \$668,167.00 in 2015 to \$317,878.00 in 2016 due mainly to absence of funding from CSSP.

Expenditures:

Overall spending for 2016 was \$347,201.00 compared to \$626,509.00 in 2015. The major decrease in spending was reflected under Work-plan and Projects with a total of only \$88,455.00 in 2016 compared to \$271,254.00

Profit/(Loss):

Despite efforts to contain spending, the Executive Council was also mindful not to compromise the services that SUNGO provides to all its stakeholders. As such, a loss of \$29,728.00 was recorded in 2016 compared to a profit of \$41,658.00 in 2015.

Conclusion:

Despite the financial difficulties faced by our Organisation during the reported year, nothing would have been possible without the concerted effort of the Executive Committee and the staff, as well as the support of our members and stakeholders.

I would like to express my appreciation to the staff of Betham Co for the time and effort put into this year's audit. The audit report accurately reflects SUNGO's performance for the 2016 year and shows that SUNGO's financial systems are sound and good internal controls are in place.

I would like to thank the SUNGO staff, for taking on additional responsibilities during the trying times of rationing both human and financial resources of our organization. I would also extend my great appreciation to our technical advisors, John and Mary Cretney, for their continual dedication and commitment to SUNGO and its members. I wish to thank all of SUNGO members and our stakeholders for your support and understanding of our financial realities during the year.

Finally I wish to thank the SUNGO President and the Executive Council for supporting me in my role as National Treasurer by making sound financial governance decisions.

OVERVIEW PERFORMANCE FOR THE YEAR

SUNGO as the umbrella body for Civil Society Organisation's is obligated to deliver activities outlined in its annual work plan. These activities aim to fulfil SUNGO's strategic plan and also to improve and fortify Civil Society competency, services and involvement.

This annual report discloses the overall progress of activities implemented and completed this year. Although the Secretariat was faced with challenges and financial constraints, important activities were implemented and completed successfully.

1. Governance & Management

This financial year has been one full of challenges to say the least. At the beginning of the year – 1 July 2015, SUNGO had a total of six staff, however, by the end of the year SUNGO were down to two staff, with volunteers able to assist when and where required.

Operationally, the Secretariat was able to complete the most important tasks with the ongoing support and encouragement from the Executive Council and Technical Advisors John & Mary Cretney. A brief report of activities completed this financial year is as follows.

2016 SUNGO Annual General Meeting

SUNGO held its Annual General Meeting (AGM) last year 30 October 2016, where the following board members were elected into office:

The Annual Executive Council (EC) & Staff retreat was held at St Therese, Leauvaa in December 2015. At this retreat, the National Secretary tendered her resignation to the EC via email and subsequently advised that their organisation was also going to withdraw as a member under SUNGO. The EC then elected an interim Secretary from the elected Council members – Lagipoiva Cherelle Jackson. Prior to the EC meeting in April, the Vice President also resigned and the EC also elected an interim Vice President also from the elected Council members – Fiu Mataese Elisara.



The main purpose of the annual retreat is to orientate the new Executive Council members on SUNGO's role and responsibilities to its member organisations and the EC's role in relation to governance and leadership in achieving SUNGOs goals and objectives. The Constitution was revised by the EC during the retreat in preparation of holding a Special General Meeting to approve amendments. With the pending completion of

the Strategic Plan, the EC identified the need to revise a new Strategic Plan moving forward and plans were put in place to ensure this important task was completed.

The retreat concluded with a number of tasks for both the Council and staff to complete prior to the end of the current financial year.

2. Communication

The Information Liaison Officer - Emanuele Taupau resigned in April 2016 after over 5 years of employment with SUNGO. During this year, two newsletters were distributed to our member organisations, stakeholders and partner organisations. A number of media releases completed for SICTP courses, workshops and meetings held by SUNGO were also submitted to the Samoa Observer for publishing.

SUNGOs new Information Officer – Fuamata Sialaoa commenced employment at the end of May and has been able to build a positive rapport and network with both media and member organisations, completing two newsletters prior to the end of the current financial year. Our website is also undergoing revisions and will be updated more regularly.

3. Institutional Strengthening

- SUNGO members organisations are empowered to effectively manage their organisations and services to their communities.
- That the management and its members have adequate skills and knowledge to carry out its programmes and activities effectively and efficiently.

Capacity building and training is a key aspect of SUNGO's work and it continues to be one of the main activities SUNGO undertakes each year. There are two avenues in which Capacity building activities are delivered: Samoa In-Country Training Program (SICTP) and SUNGO's own training program. Ongoing support is also provided along with technical assistance and mentoring through different projects.

A total of 11 courses were run throughout this reporting period from July 2015 – June 2016. Five courses were planned for the first six months of the financial year (July – December 2015). Included were three specialized courses for GOSHEN Trust, Samoa Hotel Association and Nuanua O le Alofa. There were six courses conducted in the period of January to June 2016.

SUNGO also had the chance to pilot its new course material designed by John Cretney and formally recognised by Samoa Qualification Authority (SQA) as a Non Formal Learning Module which addresses Climate Change issues and community plans under the short training contract agreement between CSSP/PPCR and SUNGO in July 2015 targeting their eight selected villages.

Two courses were run in Upolu and one course for Savaii, focusing on Project Proposal development in climate change related projects. These were the first courses offered by SUNGO using the modules prepared by John Cretney which are called Climate Change Project Design Management (CCPDM)

SUNGO has also provided significant support through the new established NGOs Trusts and CBOs as we find the increase of SUNGO memberships this year. Support provided during this reporting period includes: on-going assistance with acquittals; assistance with workplans; financial training; and liaison with board members when required. Through this support, we encourage them to attend and take part in short courses provided under the SICTP.




Training Needs Analysis (TNA)


This survey was carried out from December 2015 – January 2016 mainly by the Capacity Building Coordinator while visits in Savaii were attended by SUNGO board member Seumanu Greta Alesana. Visits to SUNGO members were an opportunity to dialogue personally and identify effective approaches specifically where there are lapses in organizations or where SUNGO is able to assist most.

The TNA visit was carried out over a week; three days in Savaii and four in Upolu. This was to ensure that all SUNGO members were covered in the site visit. The TNA exercise this year was separately conducted from the M&E and Profiling exercises. By doing this, it gives enough time for our members to discuss issues and problems faced by the organisation and agree on what improvements are needed. Most of our members' main concern is money, which is why organizations fail to sustain and survive longer. The 2015 TNA exercise resulted in the identification of 15 most requested Courses from members surveyed which were duly submitted as Requests for Proposal to the SICTP.

Training Providers and Training Delivery

This reporting period, SUNGO has only three training providers which are fewer than the previous year. We have Samoa In-Country Training Programme, CSSP – Pilot Project Climate Resilient (PPCR) and UNDP – Increased Political Participation of Women in Samoa (IPPWS).





1. Samoa In-Country Training Programme (SICTP)

SICTP under the leadership of Oloamanu Professional Training Centre, NUS offered SUNGO a total of 11 trainings and these were conducted successfully for this reporting period, FY July 2015 – June 2016. These short courses were indentified from the TNA 2015, as previously mentioned and submitted to Samoa In Country training Programme (SICTP) for approval in February 2015. Fifteen (15) 'Request for Proposals' or RFPs were submitted by SUNGO to SICTP for funding. Unfortunately, only 11 training approved due to reduction in financial assistance from the development partners. The number of offered training increased this period compared to the previous year.

Average increase in knowledge of participants who completed both the pre and post test of all training courses.



Most of the SICTP Training is delivered in English with a co trainer to facilitate translation where required. This training period saw only two overseas trainers and the majority being local trainers.

SUNGO would like to thank all the NGOs, CBOs, CSOs and Private Representatives who took the time to participate in the trainings mentioned above and acknowledge the on-going support by our local trainers who tendered for our short courses.

SICTP continually encourages SUNGO staff and our sector to be more proactive in our role especially ensuring **participation** from the Civil Society Sector to utilize opportunities and support from our funding partners which seems very low this financial year comparing to the number of courses offered more than the other sectors.



2. <u>Civil Society Support Programme - Pilot Program for Climate Resilience</u>

SUNGO signed a short training contract with CSSP in July 2015, to deliver two Climate Change Project Design Management (CCPDM) courses to 8 villages in both Upolu and Savaii. This short consultancy aimed to build skill and capacity of civil society organizations to design, plan and deliver tangible projects as stated in each Community Intergraded Management Plans that address the concerns of their target beneficiaries and communities.

This programme was conducted in the week of 20 -24 July in both Upolu and Savaii to meet timelines set by CSSP. A team of seven trainers ultimately delivered the programme. The CCPDM course was developed by SUNGO under a development contract with SQA and has recently been granted SQA Approval as mentioned above. The course is based on Climate Change adaption of the current Project Design and Management course (CCPDM) which is also approved under SQA. SUNGOs community trainers' team is very familiar with how to deliver this programme. Overall the objectives under this training contract were achieved. Programme teaching resources and assessment methodology was also reviewed.

The outcomes from these courses were satisfactory with 42 participants achieving very high scores in post workshop evaluations indicating their satisfaction with the training. It was also noted that SUNGO has new course material added to its Recognized materials under Samoa Qualification Authority which recognizes and records our short course achievements. SQA approved the SUNGO CCPDM Programme and is identified as additional intellectual property of SUNGO. There no assumptions made that this material can be taught by other training organisations.

All eight villages have had successful applications approved by CSSP. Representatives came back to SUNGO voicing their gratitude for the support provided throughout the training and are happy to continue working in partnership with SUNGO for future training.

3. United Nations Development Programme – Increasing Political Participation of Women in Samoa

SUNGO was earmarked as one of the implementing agencies for Output 1 of the United Nations Development Programme, United Nations Entity for Gender Equality and the Empowerment of Women Joint Programme.

Output 1 of this Project requires "Outreach and education on the increased political participation of women" of which SUNGO submitted a Concept Note for funding to enable its Community Trainers to deliver 15 Outreach Programs to the various communities in both Upolu and Savaii. This contract targeted a number of villages in Samoa.

The Concept Note submitted by SUNGO to UN Women specifically targeted outreach programs through engagement with communities and educating them on 4 key areas as follows:

- 1. Voter Eligibilities and Rights
- 2. Importance of Registering and Voting



- 3. The amendments in the Constitutional Amendment Act 2013 and the Electoral Act
- 4. Supporting women candidates irrespective of her political affiliation

SUNGO acknowledges the assistance by UN Women for funding this initiative and suggests that UN Women continue to push for recognition of women in the political arena through the provision of capacity building programs to raise awareness in villages and communities. Furthermore, SUNGO also recognizes the genuine partnership with the Office of the Electoral Commissioner who provided the technical expertise for the awareness programs. We believe that partnerships between government agencies and non-governmental organisations will be vital in the future and will shape awareness raising in the future to ensure that government initiatives are implemented at the ground level.



4. Policy & Advocacy

Throughout the year SUNGO has been represented on various Steering Committees with Government Ministries. These opportunities allow our Executive Council and staff to be the voice of civil society ensuring we are included in important decisions made locally.

SUNGO MEETINGS & WORKSHOPS 2016

As the recognised Umbrella for NGOs, SUNGO continues to be widespread with invitations received to represent Samoa in various meetings and seminars both nationally and internationally. These meetings and consultations include the following:

ANTI-CORRUPTION WORKSHOP, APIA - 16-17 FEBRUARY 2016

SUNGO co-hosted the Anti-Corruption Workshop held in partnership with the United Nations Pacific Regional Anti-Corruption Project (UN PRAC). The successful workshop saw a number of SUNGO members attend to participate and contribute to ways of combating and identifying corruption not only within our communities but also in Samoa.

The aim of the Workshop was two-fold. Firstly, it seeks to enhance participants' understanding and awareness of Samoa's implementation of UNCAC and ongoing anti-corruption activities. Secondly, to provide participants with a platform to discuss, share knowledge and information on possible ways to address corruption in a country context.

Based on the discussions, participants were able to identify corruption areas of concern in Samoa that they wish to share with the Government. The relevant government agencies that were asked to present on their

roles in combating corruption include the Office of the Attorney General, Office of the Ombudsman and the Office of the Auditor General. Leota Raymond Schuster, a prominent local solicitor will also spoke on anti-corruption with focus on the role of civil society in the process.

CIVIL SOCIETY MEETING – 29th APRIL 2016

One Civil Society meeting was held this financial year. The meeting was organised with only two staff employed, yet the turnout and commitment from members was very positive. Members were informed that due to the resignations of both the National Secretary and the Treasurer, the Executive Council elected replacements until the next AGM scheduled for later in the year.

As the National Liaison Unit representing Samoa in the Pacific Region, SUNGO had the opportunity to participate in the Monitoring Reporting



Round 2, for the CSO Partnership for Development Effectiveness (CPDE) in partnership PIANGO. During this Civil Society meeting, Alanieta Vakatale from the Pacific Island Association of Non-Governmental Organisations (PIANGO) travelled to Samoa to assist SUNGO in collecting feedback from civil society on identified Sustainable Development Goals (SDGs) to ensure information collected is reported on within the Pacific Region.

In addition, the information was also forwarded to the Government of Samoa for inclusion in the Report presented at the High Level Political Leaders Forum (HLPF) in New York. Samoa was the only Pacific island nation to voluntarily report against the Sustainable Development Goals (SDGs). The report was delivered by our government, and our National President had the opportunity to attend the meeting as a Civil Society representative from our Pacific region. Her travel was funded by our Regional Partner PIANGO. A copy of the report presented is available on the United Nations website.

Other issues covered in the Civil Society Meeting included an update and status of SUNGO Management and Land issues. Follow up meetings are planned for our members in the very near future.

1: General

The Samoa Umbrella for Non-Governmental Organisations (SUNGO) was incorporated on the 24 November 1997 through the initiative of 14 women organisations. It was established to achieve the following objectives:

- i. Develop and enhance co-operation and net-working amongst National Non-Governmental Organisations (NGOs) and also between National, Regional and International NGO's.
- ii. Facilitate the receiving and dissemination of information and materials pertinent to national member NGO's purpose.
- iii. Support and endorse National member NGO's development efforts relevant to the achievement for their respective goals, as well as protecting their interests and promote sharing of information and resources amongst them.
- iv. Liaise with Government and diplomatic agencies on policies and issues affecting member NGO's and the public.
- v. Support and strengthen sustainable development initiatives and promote research at all levels.
- vi. Promote Environmental Impact Assessment (EIA) on all projects to ensure sustainability.

SUNGO is designated as a not-for-profit association and it is incorporated under the Incorporated Societies Ordinance 1952 (the Ordinance).

These financial statements were approved by the Board of Directors members on

5th November 2016.

2: Statement of significant accounting policies

a. Basis of preparation

The financial statements have been prepared in accordance with the International Financial Reporting Standards. The financial statements have been prepared under the historical cost convention except as disclosed in the accounting policies below

The preparation of financial statements in conformity with International Financial Reporting Standards requires the use of estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Although these estimates are based on management's best knowledge of current events and actions, actual results ultimately may differ from those estimates.

The financial statements are prepared in Samoan tala.

b. Measurement Base

The accounting principles recognized as appropriate for the measurement and reporting of the financial performance, cash flows, and financial position on an accrual basis using historical cost are followed in the preparation of the financial statements.

c. Accounting Policies

The following specific accounting policies that materially affect the measurement of financial performance and the financial position are applied:

i. Revenue Recognition

a. Membership revenue

SUNGO recognizes membership dues on an annual basis from July to June. Dues are payable by the members in July of every year.

b. Donated services

Some donated services by Board members are recognized in these financial statements when the estimates can be reliably measured.

c. Grants

Funds received for cash grants are recognised as revenue on a cash basis. Funds received during the financial year but not yet spent are credited to *Grant Funds* in the balance sheet.

Grants received in the form of assets are recognized as deferred income and amortized to income at the same rate as the depreciation on the associated asset.

d. Projects

Funds received for projects are recognised as revenue on a cash basis.

e. Classification of income

Income is classified as donor funding and general income. Grants are regarded as *unrestricted* for the purposes of the administration and operation of SUNGO whereas project funds received are prioritized or allocated for specific project costs and cannot be used in any other area of SUNGO's operations. All other funds received are classified as *unrestricted*.

ii. Property, plant and equipment

Depreciation is calculated using the diminishing value method to write off the cost of each asset, or its revalued amount, to their residual values over their estimated useful lives as follows:

Office furniture
Office equipment
Vehicle
Buildings & renovations
15% - 25%
25% - 40%
3%

Where the carrying amount of an asset is greater than the estimated recoverable amount, it is written down immediately to its recoverable amount. Gains and losses in disposals of office furniture and equipment are taken into account in determining the results for the period.

iii. Cash and cash equivalents

Cash and cash equivalents are carried in the balance sheet at cost which is its fair value. For the purposes of the cash flow statement, cash and cash equivalents comprise cash at bank and term deposits held with banks at a maturity of no more than 90 days.

iv. Income Tax

The Institution is a non profit organization and is exempted from paying income tax under section 17 (1) of the Income Tax Act 2012.

v. Financial instruments

The association uses only non-derivative financial instruments as part of its normal operations. These financial instruments include bank accounts, term deposit, accounts receivable and accounts payable. All financial instruments are recognized in the statement of financial position at their fair values.

vi. Functional and presentation currency

The functional currency is the Samoan Tala (SAT) and all amounts are expressed or presented in Samoan Tala. Transactions in foreign currencies are translated to functional currency at exchange rates ruling at the date of the transaction. Monetary assets and liabilities denominated in foreign currencies at the balance sheet date are translated to the functional currency at the exchange rate ruling at that date. Non-monetary assets and liabilities that are measured in terms of historical costs in a foreign currency are translated using the exchange rate at the date of the transaction. Non-monetary assets and liabilities denominated in foreign currencies that are stated at fair value are translated to the functional currency at the exchange rates rules at the dates the fair value was determined.

vii. Employee entitlements

SUNGO contributed towards the Samoa National Provident Fund and Accident Compensation Corporation. Samoa National Provident Fund is a defined contribution plan in accordance with local legislation and to which it has no commitment beyond the payment of contribution. Obligations for contributions to the defined contribution plan are recognized immediately in profit or loss.

viii. Comparatives

Where necessary the prior year comparatives have been changed to conform with presentations in the current year.
